SUMMARY STATEMENT:

The Council also directed staff to engage the community and return with perception results while requesting a more comprehensive technical review of how staff prioritizes and manages street assets and how that information will guide the necessary funding needs moving forward.

In this meeting, the Council will make choices on the details of the ordinance to include adjustment of the tax rate, duration of the tax, and any additional concerns prior to the first touch on the ordinance on January 23rd.

RE: Local Option Tax Election May 2025 – December 20th, 2024

The Streets Local Option Tax (LOT) is set to expire on December 31, 2025. In August 2024, the City Council confirmed its decision to place a renewal measure on the May 2025 ballot. The Council also directed staff to engage the community and return with perception results while requesting a more comprehensive technical review of how staff prioritizes and manages street assets and how that information will guide the necessary funding needs moving forward.

- Communications Manager Erin Greaves will present the goals of the meeting, including a request for Council decisions on tax duration, adjusting tax rates, and any additional comments before the January ordinance's first touch.
- **City Manager Forest Atkinson** will lead the Council through a discussion on the Local Option Tax duration options.
- Decision Making Discussion
- First Ordinance Touch January 23rd Present Ballot Draft Prior to Election Education Prep

These sessions will provide an opportunity for the Council to review progress, discuss options, and refine the LOT proposal. The objective is to have a clear and actionable plan by January 2025, allowing sufficient time for implementation and public education.

Objectives - Key questions and areas for discussion that need answers before January 2025.

☐ Timing of the Election

- o Should we move forward with placing the LOT renewal on the May 2025 ballot? Given the necessity for a 60% approval rating to pass and the required year wait between attempts, the Council should consider the timing carefully.
- o Council decided to aim for a May 2025

☐ Flexibility in the Tax

Would the Council like to explore providing greater flexibility to the LOT?
 This could involve broadening the scope of projects or items that the tax could fund, beyond just basic street improvements. Council asked for public perceptions through engagement prior to making this decision.

Exploring Additional Projects or Items
 Would the Council like for staff to bring back options for additional projects or items that could be included in the LOT? Expanding the scope could address other critical needs within the city, providing greater value to our residents.

Adjusting Tax Rates
 Should the Council explore options for increasing the 1% retail sales tax or the 3% lodging component? Adjusting these rates could potentially generate additional revenue for priority projects but could affect voting outcomes. Council asked for public perceptions through engagement prior to making this decision.
Duration of the Tax
Legal Guidance —Staff will work with legal to discuss the use of Streets LOT funding for the varying cost components of ROW asset management, and future opportunities to leverage tax revenues for items such as planning, grant match, land acquisition, snow management, supporting PW facilities, etc., and appropriate ways to incorporate language in the ordinance to accomplish these needs with flexibility.

History Quick Summary

- Our city has a history of engaging with the public on the Local Option Tax through past elections.
- In 2014, an attempt to pass the tax narrowly failed, garnering 59.3% of the vote, just short of the required 60% threshold.
- In 2015, after making key updates and providing the public with a comprehensive streets plan, the tax passed with a 65.42% approval rating.
- These changes highlighted the importance of clear communication and transparency with residents about the uses and benefits of the tax.
- The currently approved LOT includes:
 - A 1% tax on all retail sales (excluding groceries and motor vehicles).
 - A 3% of the 6% tax collected from lodging establishments.
- These funds are designated solely for street improvements within city limits, as outlined in City Code Title 4, Chapter 11.
- The tax, effective since January 1, 2016, has been instrumental in maintaining and enhancing the city's infrastructure.
